### **Concept Note:**

The World Health Organisation declared a global health emergency on 30th January 2020 and on 11th March, a pandemic. It is estimated that 91% of the global population is now living with restricted movement. The COVID-19 crisis has affected societies and economies around the globe and will permanently reshape our world as it continues to unfold. It has brought changes to markets, economy and our daily lives. While some changes like rising unemployment, strict social distancing may begin to ease, changes in the supply chain, shift in economy and politics will be long-lasting. The solution is not likely to be global but local with different strategies emerging from different regions.

The emergences of SARS, MERS, Ebola, Chikungunya, Avian flu, Swine flu, Zika and Corona (COVID-19), have challenged our Health systems, Economic systems, Governance systems, Education systems, Social and Cultural Systems and our very lifestyles. The global impact of this outbreak began to be felt as countries around the world closed their borders, cities shut down and economies worldwide came to a virtual standstill.
